AMD&ART is a small non-profit organization working to artfully transform environmental liabilities into community assets in the Coal Country of Southwestern Pennsylvania. AMD&ART's main efforts are the revitalization of the Dark Shade Creek Watershed and the construction of an AMD treatment system and community park in Vintondale. With multidisciplinary collaboration and wide public participation, AMD&ART has taken a holistic approach to re-creating place, incorporating recreational elements, artful spaces, educational opportunities, historic reminders and restored wildlife habitat into designs for passive AMD treatment systems and brownfields redevelopment.

Throughout Coal Country, revitalizing abandoned mine lands can and will contribute to an improved quality of life that will make neglected communities more attractive to businesses and new residents. Brownfields programs in the coalfields offer a viable approach to watershed assessment and remediation planning, while AMD treatment systems, creatively designed, have the potential to re-instill a sense of place and pride, allowing community members to forge new connections to the local environment and history. Building on the community engagement of AmeriCorps and VISTA volunteers and working with watershed groups that already struggle to improve their home places, AMD&ART can bring its lessons in innovation to a wider audience in Coal Country. With CVI's assistance, we will be able to create effective outreach materials that present our approach and inspire others to work with us and make the approach their own, bringing new life to the Eastern Coal Region.

The Dark Shade Creek Watershed

In Somerset County, Pennsylvania, AMD&ART and a coalition of groups are addressing the devastating impacts of pre-regulatory coal mining and industrial abandonment in the Dark Shade Creek Watershed. Dark Shade Creek is the most polluted stem of the most polluted river in Western Pennsylvania, its watershed a blighted landscape pocked by hundreds of acres of abandoned industrial sites, former mine lands, boney piles, and twenty-one AMD discharges. The Dark Shade Brownfields Project (DSBP), funded by the EPA, is doing an inventory, assessment, and plan for the re-use of abandoned minelands and industrial sites within the watershed. This pilot project, initiated by AMD&ART and the Borough of Central City, is facilitating the collaboration of federal and state agencies, nonprofit organizations, and private industry. Together, they are addressing the real and perceived contamination that hinders redevelopment within the Dark Shade Watershed, enhancing civic activity and bringing pride back to a beleaguered watershed.

The DSBP is comprehensive in its approach to watershed restoration, with programs that include: educational outreach to schools, a vision planning initiative sponsored by the USDA, and job training, offered jointly with the Carnegie-Mellon Brownfields Center, that provides knowledge and skills to watershed residents in the environmental field. The DSBP helped community members launch the Shade Creek Watershed Association, which has taken responsibility for collecting water samples and monitoring the health of streams within the watershed. Also, the DSBP has spurred the creation of a watershed restoration and brownfields redevelopment plan that is driven and supported by the local community. The goal of this plan is to stimulate economic growth and to create opportunities for commercial business, recreational trails, and AMD treatment systems, some of which are incorporated into community parks, creating interpretive opportunities.

Vintondale

AMD&ART is nearing completion of its first project in Vintondale, which serves as a model of inclusive, multidisciplinary environmental problem solving. Community members, along with a team of

scientists, historians and artists, participated in the design of this AMD treatment system and community park. The Vintondale site is situated on thirty-five acres of reclaimed mine land, bordered by the Ghost Town Rail Trail, which is traveled by 70,000 hikers and bicyclists each year. The AMD discharge in Vintondale is relatively small and manageable; a passive treatment system and wetlands will soon cleanse the water of metallic pollutants and raise the pH to a healthy, neutral level.

But there is much more at Vintondale. Visitors will come to see an historically important coal mining site, to view birds and wildlife, to gain a better understanding of the science behind AMD and its treatment, and to learn how community based initiatives can restore the environment to health. AMD&ART is working with the residents of Vintondale to interpret the natural and historical features of the site and to develop recreational amenities and a small community educational center. The Vintondale site, once the bustling center of work and life in this company town, will again be a vital part of community life.

A Model for Coal Country

There are lessons in AMD&ART's successes and on-going work in the Dark Shade Watershed and in Vintondale, at both the watershed level and the project level, which can be applied much more broadly throughout Coal Country. Most importantly, restoring streams contaminated by AMD requires more than a technical fix. A lasting antidote to the complex problems of Coal Country must be cultural as well as environmental. A scientific solution may clean the water, but a multidisciplinary solution has the power to both clean the water and heal surrounding communities. AMD&ART has demonstrated there is great potential to reclaim and restore a part of America that has been left behind, to bring Coal Country closer to its full potential as the nation moves towards greater environmental sustainability and economic prosperity.

AMD&ART and our many partners and funders are proving we can bring about positive environmental and social change. To heal our streams and our communities, we must engage the public in such a way that there will be widespread demand for environmental improvement and the better quality of life that a healthy place can provide. Only with such constituent advocacy can we restore all of Coal Country's waterways to health, rather than treating a select few discharges. Attention will come to the problem of abandoned mine drainage through the construction of treatment systems that are integrated into artful, educational, engaging public places. To reconceptualize AMD treatment in this way is to create a paradigm shift; people will want AMD treatment systems in their communities.

With the Canaan Valley Institute's assistance, AMD&ART, the Dark Shade Brownfields Project, and the Shade Creek Watershed Association hope to create engaging and effective public outreach materials. With a great deal of progress in the past two years, AMD&ART and our partners in Dark Shade need to create outreach materials that are more up-to-date, engaging and efficient. Rather than publishing one bound document as we have in the past, we are hoping to distribute a folder that allows us to tailor information for a particular group or individual based on their specific interests. Printing several different short publications will allow us to update each area of information as necessary, rather than creating an entirely new publication when certain text become dated. Our proposal to CVI includes costs for supplies, printing and distribution of outreach materials that clearly and directly explain how the AMD&ART process could be applied to any other coal-impacted watershed of Appalachia. AMD&ART has a full-time AmeriCorps volunteer that will be entirely dedicated to our outreach effort.
