## 1. Goals

AMD&ART is both a non-profit organization and an idea, the idea that the arts and humanities are critical, necessary, components of any significant environmental remediation project. We seek to transform environmental liabilities into community assets and our process is built on community engagement. We have a small amount of funding in our Great Map Project for a local symposium on the history of the community of Vintondale, where we work, and the connections between the arts and humanities in creating the large mosaic map of this historic site as a key interpretive element. In the nearly two years since we applied for this important grant, AMD&ART has become widely recognized, even imitated, as a significant approach to engaging community and expanding perspectives in designing and implementing environmental remediation projects. Our goal for a Penn State Scholars-in-Residence is to bring the perspectives of arts and humanities faculty to assist us in developing and presenting a one-day symposium focused on this larger meaning of the work AMD&ART is doing in Vintondale.

## 2. Audiences

AMD&ART is for both local residents and for the Appalachian coal country — and all the perspectives those two contain. We will hold the symposium in Vintondale but we will seek to keep our perspective regional and multidisciplinary, like our work. Our hope would be to engage the perspectives of academic scholars in helping all of us (including the scholars as well) to better understand just what AMD&ART may be accomplishing, what it fails to address, how community and the deep understanding of the humanities can be better engaged.

## 3. Areas of Expertise, Skills, Experience

As a multi and inter-disciplinary project, we must continue to work with several disciplines as necessary, but not sufficient, members of the AMD&ART team. We would hope to have three disciplines drawn from the Penn State faculty.

History/Environmental history, particularly where the scholar has done local or coal country research and is interested in community history.

Design, particularly Landscape Architecture/ Landscape history, again with significant knowledge of coal country issues. Public Art, particularly an artist familiar with community engagement in developing public art or a commitment to that engagement and some knowledge of coal country communities.

## 4. Planning Activities

AMD&ART would meet with these three faculty on the Penn State campus several times over several months to develop and shape a symposium. We would rely on their judgment and perspective to assist in identifying significant topics or themes, the best speakers to address those themes (some might be their students doing research specifically for this symposium) and to help AMD&ART shape some way of capturing and disseminating the results of this symposium.

Because we already have a Humanities-and-the-Arts Grant for the Great Map, we would use the Great Map and its completion as a keystone for the symposium. We would begin planning with Penn State Scholars early in 2004, announce the symposium before summer and hold the event in fall of 2004.

## 5. Coordination

Dr. T. Allan Comp, historian and founder of AMD&ART will serve as Project Director, supported by the AMD&ART staff of three AmeriCorps and VISTA members. We have close linkages with the community, own the old church in which the event will take place and have developed and presented large events in the past.

#### Terms of Penn State Scholars-in-Residence:

- Your participation consists of a one-day residency with one scholar. Your scholar will be available
  for follow-up after the residency.
- Using the scholar's profile which you provided in your application, we will find an appropriate scholar for your project.
- Your project may begin in late January/early February 2004.
- The IAH and the PHC will cover your scholar's honorarium and travel expenses.
