AMD&ART is a non-profit organization that is artfully transforming environmental liabilities into community assets in Southwestern Pennsylvania. The AMD&ART process is one that combines public art, environmental improvement and community engagement in treating abandoned mine drainage (AMD), the most widespread environmental, economic and social problem of the Appalachian region. Using multidisciplinary intervention and wide public participation, AMD&ART has created a holistic approach to re-creating place that incorporates recreational elements, artful spaces, educational opportunities, historic reminders and restored wildlife habitat into designs for passive AMD treatment systems. This approach honors a past of hard work and community building, bringing that same civic engagement and hard work to the design and construction of treatment systems that reach people, restore nature and revitalize abandoned spaces.

Our first site is in the Borough of Vintondale, Pennsylvania, a small coal patch town in Cambria County, some 15 miles northeast of Johnstown, nestled deep in the Blacklick Creek Valley. Vintondale is a community whose history is defined by underground mining and vast surface works, yet the tangible reminders of this proud past are beginning to fade away. In the 1960s, the last deep mine in Vintondale closed forever. As the procession of miners across the footbridge of the coal complex ceased, so did the sounds of the tipple, the smoke from the railroad, and the nighttime glow of the coke ovens.

What was once a bustling mining center with multi-story buildings is now silent, covered with boney, the past rendered invisible. But, this vacant field of scrubby grasses and stunted trees is currently in the process of transformation into a large-scale work of environmental art. The 35-acre site in Vintondale offers a manageable AMD discharge in a location central to the community, with high visibility due to the popular Rails-to-Trails hiking and biking trail that borders the site.

Today, the riverbed is blanketed with orange sediment from abandoned mine drainage, and the streets are lined with dilapidated houses. Vintondale's population of 582 is a quarter of what it was at the height of the mining industry, and 61.9% of families with children live in poverty. The per capita income is \$10,957, and only 7.7% of the population over 25 has a college degree. What statistics cannot show is that hope is still very much alive in Vintondale, and residents of the Blacklick Creek Watershed are working to clean their waterways and revitalize their communities.

The AmeriCorps and VISTA volunteers of AMD&ART are the core of outreach and capacity building for the AMD&ART team, and are the critical link between concept and reality, artist and community. People of all ages have worked with the AMD&ART team to move the Vintondale project forward, from school kids to seniors. What they are building is more than just a park or a treatment system; they are building connections between generations and families that will make their community more cohesive and resilient. AmeriCorps volunteers work directly in service to the communities we serve, organizing volunteers and coordinating community participation. VISTA volunteers work to increase civic engagement and to build the institutional capacity of AMD&ART. The work of both allows AMD&ART to create our pilot site in Vintondale and then to expand our efforts to the 34-square mile watershed of Dark Shade Creek.
