Dear Mr. Comp:

Your organization agrees to submit to Tides a progress report (preferably a two page narrative and financial report) by August 13, 2001 describing the use of the funds and activities undertaken as a result of this grant. Please forward grant reports to Jason Sanders, Donor Services Officer in our office, via email at jsanders@tides.org and to Potrero Nuevo at fund@potreronuevo.org. The report should include the following: grant identification number; major staff and programmatic changes; other funding received and how it was used; how goals were realized; any modification of strategies in light of changing issues; significant challenges and how your organization dealt with them; your board of directors' role in helping your organization meet goals; news clippings and other relevant material.

Your organization agrees to show these grant funds separately on its books; however, your organization is not required to segregate these funds in separate bank accounts. All expenditures made for the purposes of the grant shall appear on those books, and your organization agrees to make such books and records available to

the Tides Foundation at reasonable times upon request. Your organization also agrees to keep copies of all books, records, and reports to Tides for at least four years after completion of the use of the funds.

Your organization agrees not to use any portion of the granted funds to: carry on propaganda or to attempt to influence specific legislation either by direct or grassroots lobbying; influence the outcome of any specific voter registration drive; make grants to individuals on a non-objective basis; or support any non-charitable or non-educational purpose.

If this grant is made for the purchase of capital equipment or for capital endowment, your organization agrees to submit reports to Tides, for this taxable year and for your organization's two succeeding taxable years, describing the use of the principal and income (if any) derived from the granted funds.

If you have occasion to announce or acknowledge this grant publicly, please indicate that support was provided by the Potrero Nuevo Fund of the Tides Foundation.
